Rhea Vendors Group Spa. General Conditions of sale:

1. Area of application: these General Conditions of Sale of Rhea Vendors Group S.p.A. regulate all sales agreements entered into between Rhea Vendors Group S.p.A. and the purchaser. On receipt of our order confirmation, and in the absence of written objection within 15 days or from the time of delivery, the General Conditions of Sale shall be considered as being unconditionally accepted by the purchaser, with the express renunciation of any exception. Any departures from our variations in these conditions will be valid only if agreed at the time the contract is drawn up and documented in writing. These conditions supersede those applied in the individual countries of sale where they do not contravene the laws on that country. If a clause contravenes a law in force in the country of sale, it will be substituted with a clause having the nearest commercial sense to the former. Any conditions of purchase made public by the purchaser will be considered valid only if notified to Rhea Vendors Group S.p.A. and approved in writing.

1a. Definition of parties: The parties are: Rhea Vendors Group S.p.A., with premises in Via Valleggio 2 bis, Como and all its associated companies, including Rhea Vendors Industries S.p.A., MPR S.p.A. and DAMIAN S.r.l. for the purposes of these conditions, the purchaser is defined as the reseller, distributor, operator and/or manager involved in an agreement of sale with Rhea Vendors Group S.p.A.

2. Orders: on placing an order, the purchaser declares that it accepts these General Conditions of Sale. The order is irrevocable and binding on the purchaser and as an exception to art. 1329 CC, constitutes a full agreement and not a proposed agreement, while on receipt of the order Rhea Vendors Group S.p.A. has the right to refuse the same. Only the end user, with the exception of companies and resellers (art. 2 a Legislative Decree 50/92), being entitled to exercise the right of withdrawal, orders placed by the purchaser with Rhea Vendors Group S.p.A. are not protected by the right of withdrawal. In the event of cancellation or failure to complete the contract due to an act of fault of the purchaser, Rhea Vendors Group S.p.A. will consider any amounts paid on account to be its property, reserving the right to claim for greater damages. Following delivery and the goods being deemed to be in compliance with the specifications of the order, the purchaser will not be entitled to make any complaint with regard to the working or appearance of the products. Any agreement regarding to exchange of goods must be in writing and will result only in goods being substituted, to the exclusion of any other claims by the purchaser.

3. Prices: prices and terms and conditions of payment are those specifically indicated in Rhea Vendors Group S.p.A.'s confirmation of order, with the exception and applicable contracts. Unless differently agreed in writing, prices are understood to be FBO ex works, net or VAT, charges for assembly, installation, functional modifications, approval of the goods or taxes, and do not include any charge or service not explicitly mentioned. On the case of contractually agreed prices, frozen prices of specific machine models will lapse when any modification is made to the model, the purchaser being given prior notice of such modification. Prices may be varied or changed without prior notice, even between the date of acceptance of the order and the delivery date, and without the purchaser having the right to object, whenever changes are made in customs or fiscal regulations or other connected factors due to circumstances beyond the control of Rhea vendors Group S.p.A.

4. Payment: the terms and conditions of payment are those expressly indicated in the order confirmation. Invoices issued by Rhea Vendors Group and not disputed in writing within 15 days of the date of receipt are considered explicitly and definitively accepted. The purchaser has no right to defer or suspend payment. In the event of late payment, the interest on arrears provided for in art. 5 of leg. Decree 231/2002 will be applied to run from the date on which payment was due, also in the absence of a written demand by Rhea Vendors Group, which reserves the right to partly or wholly cancel the purchaser's orders or to suspend delivery, giving the purchaser written notification, including by electronic mail. The cancellation or suspension will take effect should the purchaser not make the payment due within 3 working days of receipt of same.

5. Reservation of ownership: in terms of articles 1523 and subseq. of the Civil Code, the goods which are the object of an agreement of sale remain the property of Rhea vendors Group until the price has been paid in full. In the event of seizure or attachment of the goods, the purchaser undertakes, at its own expense, to inform any third party of and assert the reserved ownership rights.

6. Default: the purchaser renounces in advance any claim to the difference between its obligation to pay the full price and anything of any nature owed to it by us. In the event of failure to make payment at the agreed time, the purchaser forfeits the benefit of time in terms of art. 1186 and hereby authorized us to levy execution on him for payment of the entire amount owned. We also have the right to re-acquire the immediate and full use and possession of the goods and to appropriate the amount paid up to then as compensation for damages, reserving the right to take action to claim for the greater damage. In the event the purchaser does not spontaneously arrange for restitution of the goods, in terms of these conditions it authorizes Rhea Vendors Group to enter the premises where they are installed to remove same at the expense and risk of the purchaser, who undertakes to raise no objections of any kind. In addition, no claim or defense can be legally brought by the purchaser where the latter is in arrears with payment.

7. Terms of delivery: the delivery terms indicated in the order confirmation are to be considered as purely indicative and are not binding in any way. They refer to goods consigned FOB ex works Rhea Vendors Group's manufacturing facilities, and are established on the basis of the company's production capacity in normal supply and work conditions. Rhea Vendors Group reserves the right to vary them on the basis of its unchallengeable decision, giving the purchaser timely notice of the change. The purchaser may not, in any case cancel the order, and hereby undertakes not to demand compensation for any direct or indirect damage caused, including to third parties, by late delivery.

8. Transport: orders are withdrawn and consigned FOB ex works. Storage times at the production facilities must not, however, exceed 30 days, beyond which an amount of Euro 90,00 per week per pallet of available goods will be charged. Rhea Vendors Group reserves the right to transport and store goods at the logistics centre at the customer's expense and risk transport costs and in any event for the account of the customer, who assumes the entire risk and danger of transport even where carried out by Rhea Vendors Group vehicles. Rhea Vendors Group is in no way obliged to substitute or credit material tempered with, damaged, lost or stolen in transport.

Rhea Vendors Group reserves the right to transport and store goods at a logistics centre at the customer's expense and risk transport costs are in any event for the account of the customer, who assumes the entire risk and danger of transport even where carried out by Rhea Vendors Group vehicles. Rhea Vendors Group is in no way obliged to substitute or credit material tempered with, damaged, lost or stolen in transport.

9. Installation: prices do not include the costs of installation, erection, connection or assembly, except in those cases agreed in writing. Rhea Vendors Group Spa. accepts no liability for installations, connections, or assembly carried out by third parties.

10. Complaints and tacit acceptance: any complaints regarding products supplied must be made to Rhea Vendors Group's customer service department, within 15 days of delivery of the goods. In the absence of complaints, the purchaser is considered to have accepted the goods and declared that it has received goods that correspond in every way to those it intended purchasing and are comply fully with what was specified in the order confirmation.

11. Guarantees: goods produced and sold by Rhea Vendors Group are guaranteed against any manufacturing defects for 12 months from the date of shipment. The validity period of the guarantee is not subject to extension nor is it suspended during repair times. In the case of manufacturing defects, the purchaser must inform us 1. within eight days of the goods in the case of an immediately evident defect; 2. within eight days of the date of discovery of a hidden defect or of the date on which a diligent buyer should have discovered it. In the event the purchaser does not notify Rhea Vendors Group of the defect within the time limits provided for, it relieves us of any liability and forfeits the right of guarantee. In addition, any legal action taken by the purchaser with regard to the guarantee must be initiated within twelve months of the date of delivery of the goods. In any event, the guarantee exclusively covers faults that cause the products to malfunction and defective components. Rhea Vendors Group S.p.A., therefore, reserves the right to decide whether to repair the faulty part or replace the whole item. Repairs and replacements will be carried out exclusively at our premises. Any services performed elsewhere, including Rhea Vendors Group's overseas branches, will be charged for. The costs of transporting goods or parts is wholly for the purchaser's account. The guarantee is not applicable in the case of: 1. normal wear of parts subject to wear and tear during use; 2. elements with a normal lifespan of less than the guarantee period; 3. items which have been improperly stored, installed, used, maintained, repaired or cleaned; 4. items modified by third parties; 5. damage caused by abnormal water pressure or erratic voltage in electricity lines or hard, ferruginous or dirty water; 6. damaging events without liability on the part of Rhea Vendors Group. The provision of services under the guarantee and any delay in same do not give the purchaser the right to suspend payments. In addition, in the case of delays or insolvency, even partial, Rhea Vendors Group is exonerated from its obligations under the guarantee.

12. Limitation of liability: neither party is liable to the other for damages caused by loss or profit or income or other indirect damages. All the parties' liabilities are defined by what is explicitly expressed in these General Conditions of Sale, with the exclusion of any other right not provided for herein, such as additional contractual or non-contractual rights of cancellation, withdrawal, restitution or price reduction. In addition, the purchaser secures Rhea Vendors Group against any obligation to pay compensation, charges, costs or expenses, including legal, which may arise from the claims of third parties deriving from use of the goods, and assumes complete liability for the operativeness of same. Rhea Vendors Group's liability is limited to that which is expressly provided for in these conditions.

13. Force Majeure: the parties shall not be liable for delays or inability to fulfill contractual obligations caused by conditions beyond their control, such as natural catastrophes, fires, strikes, revolts, wards, acts of terrorism, law or government regulations that impede the fulfillment of an order. When conditions beyond its control occur, the defaulting party will supply the other party with detailed information within 5 days of the event. In the event the delay in performance is more than 50 days, the other party will have the right to cancel the unfulfilled part of the contract with incurring any liability.

14. Excessive onerousness: in the event the service offered becomes excessively onerous as a result of extraordinary or unforeseeable events, Rhea Vendors Group S.p.A. reserves the right to request cancellation of the contract in terms of art. 1467 c.c.

15. Undertaking to supply fiscal documents: the purchaser who acquires goods for the purpose of transporting them outside the European Union undertakes to return within 30 days from consignment of same, the third copy of the customs export bill endorsed by the EU customs through which same were exported. Otherwise, Rhea Vendors Group S.p.A. will have the right to debit the VAT relating to the order to the purchaser, as well as any sanctions or sums of any nature which may be applied by the relevant authorities.

16. Principle of preservation: in the event one or more clauses of this contract are or become void, the other clauses will remain entirely valid. The void clause shall be substituted by a valid clause that is as close as possible to the commercial sense of the void clause.

17. Jurisdiction: any contestation or dispute regarding the sales agreement covered by these General Conditions of Sale will be referred to the Milan Court. In the event Rhea Vendors Group S.p.A. is the plaintiff, it reserves the right to initiate legal proceedings either in the Milan Court or that having jurisdiction over the purchaser. In any case, legal relations between the purchaser and Rhea Vendors Group S.p.A. will be governed exclusively by Italian law.

18. Personal data: in terms of Leg. Decree 196/03 on privacy, the parties declare that they accept the collection of personal data required to formalize this deed in Rhea Vendors Group S.p.A.'s information system and archives for the proper management of the company's obligations. The purchaser gives permission for the data to be processed for management, statistical and commercial purposes. The parties expressly declare that they are aware of the contents of art. 7 of the abovementioned decree. In addition, the purchaser relieves Rhea Vendors Group S.p.A. of any liability for the fraudulent use by third parties or errors in electronically transmitted data.
